We are writing to formally request a New Exporter Review (NER), in relation to Trade Remedies Notice 2025/10, concerning alleged dumping of certain self-propelled track-laying excavators imported into the United Kingdom from the People's Republic of China.

This request is submitted on our behalf by **name redacted** UK Ltd, who is acting as our authorised representative in the United Kingdom.

We respectfully submit the following declarations in support of our eligibility for a New Exporter Review:

**1. No Exports During Investigation Period**

Zoomlion Heavy Industry Science & Technology Co., Ltd. did not export the goods concerned to the United Kingdom during the original investigation period of 1 July 2022 to 30 June 2023. Please see Appendix 1 where we share our sales figures.

**2. No Association with Other Exporters**

We confirm that Zoomlion Heavy Industry Science & Technology Co., Ltd. is not related to any exporter or producer of the goods concerned who did export to the UK during the investigation period. Furthermore, we remain unaffiliated with any other brand or manufacturer currently subject to the measures under Trade Remedies Notice 2025/10. Please see Appendix 2 for a list of directors during these years

**3. Strategic Entry into the UK Market**

Zoomlion is now actively pursuing plans to introduce a full range of excavators into the UK market. This includes models within the scope of the investigation, supported by local distribution, service infrastructure, and long-term investment in the UK construction machinery sector, plus creating jobs for the UK. We are fully prepared to cooperate with the Authority and provide any further documentation, to support a fair and transparent review.
