Instructions

The Trade Remedies Investigations Directorate (TRID) of the United Kingdom's Department for International Trade is carrying out a transition review of safeguard measures active under the EU system that the United Kingdom (UK) decided to transition after EU exit. This transition review will assess whether the safeguard measures on certain steel products should be maintained, varied or discontinued in the UK. It will also consider whether the current safeguard measure should be extended.

IV - Why you are being asked to complete this pre-limited examination questionnaire

We are seeking your cooperation as a **UK importer** of the goods subject to review to the UK, to inform our review of whether the current safeguard measure should be maintained, varied, discontinued and/or extended.

This pre-limited examination questionnaire allows us to collect basic information and data about your company. If a large number of UK importers complete this pre-limited examination questionnaire, we will use the information each one provides to help us decide which companies we want to sample for further investigation.

V - Who should complete this form

You should complete this form if you are a UK importer of the goods subject to review.

If you are not a UK importer, please complete either the relevant Pre-Limited Examination Questionnaire or the relevant Registration Form.

VI - Deadline for response

Please submit your completed questionnaire to us via the Trade Remedies Service no later than **15 October 2020**. VIII - Period of Investigation

The period of investigation is **1 January 2013 to 31 December 2017** reflecting the period of the original EU investigation.² During the investigation, TRID will use data provided for the period of investigation to assess whether the safeguard measure on certain steel products should be maintained, varied or discontinued in the UK.

IX - Most recent period

The most recent period is **1 January 2018 to 30 June 2020**. During the investigation, TRID will use data provided for the most recent period to assess whether the safeguard measure on certain steel products should be reduced or extended in the UK.³

² This is the period of investigation set out in the EU Regulation.

³ The MRP is the period which begins immediately after the end of the POI (as specifically defined under reg. 49(4) of the SG Regs. (as amended)) and runs up to the end of the most recent TRQ quarter before initiation of the review. Data for this period is needed to help us consider whether it is appropriate to reduce or extend the period for which the safeguarding measure applies to the goods concerned in the review.

Import and distribution of Cat5 Organically Coated Steel strip products for use in Industrial and Agricultural building envelope applications.

3. Please describe your interest in this case:

DUK are an historic supplier (over 15 years trading) of Cat5 Organic coated strip products to the UK roofing and cladding end user market. The majority of our OCS imports originate from South Korean producers, Duferco UK having developed quality products for over a decade.

Our specific interest is for the correction of the import statistics to correctly reflect the historic trade flow for this product group, cat 5. Safeguard measures announced 30/09 have applied a tariff free quota for South Korea 3,798mt Q1 and 3,841 Q2 2021. Historical



quarterly volumes are closer to 13k mt. A huge reduction in the free quota allowance and a severe problem for the UK consumer who are reliant on this historic import.

Prior to 2015 we were trading the same Cat5 products for Stemcor Global Holdings Limited, in today's market we share 50/50 the import market. Our figures relay only to Duferco imports but consideration as to the total market should be taken from Stemcor questionnaire also.
