Universal Tubes and Plastic Industries Ltd (UTP) is located in Jebel Ali Free Zone, United Arab Emirates. UTP manufactures High Frequency Welded Steel Pipes and Tubes in Black, Painted and Galvanized finishes. The mill's manufacturing size range consists of Round pipes from sizes ½" to 6", Square tubes from size 19x19 to 125 x 125 and Rectangular tubes from size 40x20 to 150x100 in thicknesses from 1.5 mm to 7.1 mm, using various material grades and also as per customer requirements. UTP exports material to various countries around the world, including the United Kingdom (UK). UTP has been exporting material which is covered under the proposed safeguard measures on certain steel products to the UK for the past 20 years.

2. Please describe your interest in this case:

We supply UAE manufactured pipe and tubes to the UK which fall under the safeguard measures on cert steel products.

Currently we are supplying approximately [REDACTED] per annum of Gas pipes (Category 20), Hollow section (Category 21), and Other welded tubes (Category 26). The current quotas mention in UK safeguard on certain steel items for UAE are significantly below our current volumes to the UK.
