The scope of this investigation

Goods concerned

This **investigation** covers **goods** originating in the **United States of America (US)** described as:

Biodiesel (or paraffinic diesel fuel / gasoil) obtained from synthesis or hydrotreatment of oils and fats of non-fossil origin, in pure form or as included in a blend, originating in the United States of America (US). This biodiesel is commonly known as hydrotreated (hydrogenated) vegetable oil diesel (HVO), renewable diesel or green diesel. Synthetic paraffinic kerosene (also known as sustainable aviation fuel (SAF)) is excluded from this description of biodiesel.

Valero Energy Ltd is a subsidiary of Valero Energy Corporation (NYSE: VLO).

Valero Energy Corporation ("Valero"), through its subsidiaries, is an international manufacturer and marketer of transportation fuels, and a leader in the commercialisation of emerging low-carbon intensity biofuels. Valero is a Fortune 50 company based in San Antonio, Texas, and it operates 15 petroleum refineries located in the United States, Canada and the United Kingdom with a combined throughput capacity of approximately 3.2 million barrels per day and 12 ethanol plants with a combined production capacity of approximately 1.69 billion gallons per year.

Valero, through a subsidiary, owns 50% of Diamond Green Diesel Holdings LLC ("DGD"), a joint venture whose facilities in Louisiana and Texas, currently produce renewable fuels, including renewable diesel and synthetic paraffinic kerosene.

In the UK, Valero Energy Ltd owns and operates Pembroke Refinery in south west Wales, which is one of Europe's largest and most complex refineries, has ownership interests in four major pipelines, eight fuel terminals and a large aviation fuels business.

Affordable low carbon liquid fuels will be essential to meeting the UK's goal of achieving emission reduction targets by 2050.

As Valero Energy Ltd has consistently maintained with the TRA in the various biofuels investigations to date, we are interested in ensuring that trade barriers do not unnecessarily interfere with the market in order to provide the lowest cost, most efficient supply of biofuel to meet these objectives.

Valero Energy Ltd strongly objects to the scope of investigations as presented by the Applicants. HVO and FAME are not "like products". HVO is chemically very different and these differences mean it is handled fundamentally differently in the marketplace. These differences were exacerbated in recent years, as HVO continued to gain significant traction as a distinct commodity on the UK market due to its unparalleled quality and greenhouse gas emissions reduction properties.

To Valero Energy Ltd's knowledge there are no producers of HVO in the UK. As there is no UK production of HVO, the Applicants who represent only the UK FAME industry, do not have a standing to initiate the investigations. Therefore, the UK market is completely dependent on imports of HVO. UK domestic production is unable to satisfy the RTFO targets, necessitating imports of HVO. Imposing measures on imports of HVO from the US would not be in the interest of the UK consumers.

Valero Energy Ltd will share further comments on the product scope of the case concerned as a separate submission.

D3 – Product Control Numbers
