## The scope of this review

### Goods subject to review

This review covers certain excavators exported from the People's Republic of China, described as:

Self-propelled track-laying (tracked) excavators with a 360-degree, revolving superstructure and with an operating weight of 11,000kg (11 tonnes) or more, but less than 80,000kg (80 tonnes)

The goods subject to review are subject to the following UK Global Tariff commodity code:

8429 5210 00

This code is only given for information and includes 'mini' excavators under 11 tonnes and excavators over 80 tonnes, which are not in scope of this investigation.

In this document, these goods will be referred to as **the 'goods subject to review'**. Any reference to the **'goods subject to review'** in this document refers to the goods description above, regardless of the commodity code under which they are exported.

### Like goods

Any reference to **'like goods'** in this document refers to goods produced in the UK or imported to the UK from a country other than the People's Republic of China which are like the goods subject to review in all respects, or with characteristics closely resembling them.
