

Timeline of China's rubber industry in 2020

Grand opening of GM (Thailand) Company

On January 1th, General Rubber (Thailand) Co., Ltd. was grandly opened in Rayong Industrial Park, Thailand! This is GM's first overseas production base and the fifth Chinese tire company to be built and put into operation in Thailand. The plant, which covers an area of about 9,5 square meters and has a total investment of US\$51 million in the first phase, is one of the largest projects invested by a Chinese manufacturing company in Thailand in 3. The project was successfully put into trial production on December 2018, 2019, with an annual output of 12 million all-steel tires and 28 million semi-steel tires.

Baotong Technology won the second prize of National Science and Technology Progress Award

On January 1, at the 10 National Science and Technology Award Conference, the project "Key Technology and Engineering Application of Special High-performance Rubber Composite Materials", co-hosted by Baotong Technology and Beijing University of Chemical Technology, and participated by China Chemical Industry Guilin Engineering Co., Ltd., won the second prize of National Science and Technology Progress Award, which is the first national award won by the conveyor belt industry so far.

Linglong Jingmen plant put into production of passenger tires

Following the start of truck and bus tire production on December 2019, 12, Hubei Linglong Tire Co., Ltd. started production of passenger car tires on January 11, which is the fourth plant in China built by Linglong Tires. The project covers an area of nearly 1,11 mu, with a total investment of 4.1400 billion yuan, and an annual output of 54 million semi-steel tires, 1200.240 million all-steel tires and 6, <> engineering radial tires.

The United States lowered the countervailing duty rate on engineering tires in China

On January 1, the U.S. Department of Commerce issued an announcement revising the final ruling of the 13th Administrative Review of Countervailing Machinery Tires imported from China in accordance with the judgment rendered by the U.S. Court of International Trade on December 2019, 12. The final ruling result of the revised antivailing administrative review is lower than the original final ruling rate. Among them: Guizhou tire subsidy rate is 26.7%, Xuzhou XCMG is 19.78%; In addition, the countervailing duty rate for 46 unselected enterprises, including Xiamen Zhengxin, CRRC Shuangxi, Qingdao Aotai Rubber Co., Ltd., Qingdao Maisteon Tire Co., Ltd., and Tianjin Guolian, was 31.44%.

The China Rubber Association actively coordinates the allocation of national anti-epidemic materials

On January 1, the China Rubber Industry Association received a call from the Ministry of Industry and Information Technology, hoping to assist in the emergency deployment of 23,200 pairs of protective rubber boots for reinforcement in Wuhan. The rubber shoe branch of the China Rubber Association immediately contacted the member companies Nanjing Tianlihe Trading Co., Ltd. and Henan Hebi Feihe Co., Ltd., and the heads of the two companies immediately expressed that they would provide material support at any time. Considering the seriousness of the epidemic and emergency needs, on the afternoon of the 23rd, the rubber shoes branch of China Rubber Association issued an emergency notice through the public account, mobilizing member companies to provide the inventory of protective rubber boots and emergency contact information in case of anti-epidemic materials.

This move has received a positive response from a number of member companies, which have reported their inventory and contact information at the first time, and expressed their support for national deployment and use at any time.

On January 1 (the second day of the Lunar New Year), the China Rubber Association received a call from a national organization, hoping to assist in the deployment of medical gloves. The latex branch of the China Rubber Association immediately recommended the association's director unit, Zhenjiang Hui Latex Products Co., Ltd., which immediately urgently provided 26,40 disposable rubber inspection gloves for it.

The China Rubber Association announced the results of the phased investigation of the impact of the epidemic on the industry

On February 2, the China Rubber Industry Association launched a questionnaire online on the impact of the new crown pneumonia epidemic on the production and operation of rubber industry enterprises. As of February 7, a total of 2 questionnaires have been collected, and the China Rubber Association has released phased (February 12~25) survey results on the scale of enterprises involved in the questionnaire, the resumption of work and production affected by the epidemic, the market, exports, expected benefits, etc., as well as the existing problems and demands, etc., to provide a basis for relevant national departments to solve problems and introduce relevant policies.

The China Rubber Association actively investigates the resumption of work and production and reflects the demands of the industry

On February 2, the China Rubber Association received an urgent notice from the Ministry of Industry and Information Technology and the National Development and Reform Commission, requesting statistics on the proportion of resumption of work in various industries, existing problems and policy recommendations. After receiving the notice, the China Rubber Association tire, force tire type, hose tape, rubber products, rubber shoes, latex, waste rubber comprehensive utilization, carbon black, rubber machinery mold branch, rubber additives, skeleton materials, rubber materials, rubber testing special committee and marketing working committee, immediately through telephone and other forms of extensive understanding of the production operation and resumption of work and production of the enterprise and the existing difficulties, and reported the professional situation to the general association of the China Rubber Association, and at the same time released the economic operation of the industry and the resumption of work and production in stages in the media of the association.

On February 2, the China Rubber Industry Association submitted a "report on the rubber industry's fight against the epidemic to ensure economic operation and the resumption of work of rubber enterprises" to the National Development and Reform Commission, the Ministry of Industry and Information Technology, and the China Petroleum and Chemical Industry Federation. The report summarizes the work of the rubber industry to fight the epidemic and ensure economic operation through comprehensive enterprise online filling data and offline professional branch member companies' actual statistics as of February 14, including the resumption of work of enterprises, the main problems and suggestions.

Brazil imposes anti-dumping duties on Chinese bicycle tires for another 5 years

On February 2, the Brazilian Foreign Trade Commission issued Resolution No. 19 of 2020 in the Federal Government Gazette, making the first final anti-dumping review ruling on bicycle tires originating in China, India and Vietnam, and continuing to impose anti-dumping duties on the products involved in China, India and Vietnam for a period of 13 years, and the tax rate of Chinese products is 5.0~29.3 US dollars / kg. The announcement said that the anti-dumping measures in this case did not apply to tires made of Kevlar. The tax code of the product involved is 85.4011.50.

On February 2, the China Rubber Industry Association reported to the Ministry of Industry and Information Technology and other relevant departments for the second time the rubber industry's fight against the epidemic, ensuring economic operation and the resumption of work and production of rubber enterprises. As of February 24 and 2, China Rubber Association has conducted two offline

surveys on various industry segments, and at the same time surveyed 12 enterprises through online questionnaires, and learned about the resumption of work and production in various stages of sub-industries and the seven major problems faced by enterprises: personnel and resumption of work applications, increased production and operation costs, logistics and transportation and supply chain, shortage of enterprise protective equipment, product exports, weak domestic market, tight working capital, etc. At the same time, the China Rubber Association put forward five suggestions to relevant national departments: ensure the normal production of enterprises and accelerate the opening of special logistics channels; Adopt interest rate cuts and discounted loans to stabilize the flow of corporate funds; Establish green export channels and appropriately increase export tax rebates; Strengthen the screening of returnees to ensure epidemic protection supplies; Give preferential policies in terms of relevant taxes and electricity prices.

The China Rubber Association released ten major impacts of the epidemic on the production and operation of rubber enterprises

On March 3, the China Rubber Industry Association summarized 13 online questionnaires through the online "Questionnaire on the Impact of the Novel Coronavirus Pneumonia Epidemic on the Production and Operation of Rubber Industry Enterprises", and released ten major impacts of the epidemic on the production and operation of rubber enterprises, including: enterprise scale, resumption of work, capacity recovery, changes in the use of enterprise capacity compared with the same period of the previous year, enterprises building factories overseas, domestic and foreign markets affected and restricted, expected fluctuations of major raw materials in the first quarter, It is expected that the impact of the epidemic on the company's revenue and profit in the first half of the year, the impact of the epidemic on the company's export, the company's capital turnover and prospect forecast.

Yiyang Rubber Cloud signed a large order of 1600 million yuan

On February 2 and 4, Yiyang Rubber and Plastic Machinery Group Co., Ltd. successfully signed orders for mixers and flat vulcanizing machine maintenance projects with customers in Vietnam and Jiangsu, China through cloud bidding cloud signing, which launched the first shot of China's chemical cloud marketing war "epidemic". Before the epidemic was over, Yiyang Rubber Machine replaced "face-to-face" from "screen-to-screen" and "online connection" instead of "hand-in-hand" to explore new industrial development opportunities and improve the online landing efficiency of cooperation projects.

Sailun (Dongying) 2700 million articles project launched

On February 2, the high-performance semi-steel tire expansion project of Sailun Dongying Plant was officially launched. With an investment of about 21 billion yuan, the overall plan is to adopt the world's most advanced production equipment and fully automatic tire logistics line, deeply use artificial intelligence technology, build a data- and AI-driven full-life cycle tire intelligent manufacturing system, and introduce the "liquid gold" tire technology of Sailun Group into the production line to achieve mass production at Dongying plant. With an annual output of 10 million semi-steel tires, the project will become the world's largest production base for high-performance semi-steel tire monomer factories.

China Rubber Association released recycled rubber and rubber shoes group logo

On February 2, the China Rubber Industry Association issued three group standards, namely: "E series recycled rubber softener" (T/CRIA 26-3), "functional shoes Part 21002 Technical specifications for anti-slip evaluation" (T/CRIA 2020.1-17003), "Functional shoes Part 1 Technical specifications for cold protection evaluation" (T/CRIA 2020.2-17003), all of which have been implemented since March 2.

Shengao Chemical's first overseas plant was built in Thailand

On March 3th, Shengao Chemical Technology Co., Ltd., a subsidiary of Shengao Chemical Technology Co., Ltd., officially started construction in Logana Industrial Park, Chonburi Province, Thailand. This is the sixth production base of Shengao Chemical and the first overseas production base, with a total investment of about 9 million yuan, covering an area of about 6,2 square meters,

and has an annual production capacity of 9,6 tons of rubber antioxidants after completion. The factory plans to build the Thai factory into a new generation of smart and smart factories guided by the Smart Sennics digital strategy and combined with the digital transformation experience of domestic factories.

The largest overseas order shipment after the resumption of work of Guilin Rubber Machine

On March 3, tractors loaded with Turkish customers' OTR tire vulcanizing machines drove out of Guilin Rubber Machinery Co., Ltd., which is the largest export equipment shipped by Guilin Rubber Machinery since the resumption of work after the Sri Lankan project order went to sea smoothly on February 12. So far, Guilin Rubber Machinery has provided 2 batches of more than 27 vulcanizing press products to the Turkish customer, involving hundreds of millions of yuan. With a total amount of 6 million yuan, this project is the largest project since cooperation with Turkish customers, including 200-inch, 7000-inch, 78-inch OTR tire vulcanizing machine with different specifications.

In the last period, the institute helped rubber farmers to fight the epidemic and resume production

On March 3, the Shanghai Futures Exchange announced to accelerate the launch of the 12 natural rubber "insurance + futures" precision poverty alleviation pilot work, investing a total of 2020 million yuan in anti-epidemic poverty alleviation funds, uniting 1 futures companies and 5 insurance companies to provide price guarantee for nearly 44,4 tons of natural rubber in 25 counties, providing price support for 19,10 rubber farmers, and helping rubber farmers and the rubber industry to fight the epidemic and resume production.

The state increases the export rebate rate of relevant rubber products

On March 3, the Ministry of Finance and the State Administration of Taxation jointly issued Announcement No. 17 of 2020, deciding to increase the export rebate rate for some products. Including 15 products related to the rubber industry, including rubber additives, some hoses, rubber products, and synthetic rubber, the adjusted tax refund rate will be increased to 27%. This measure has been implemented since March 13, 2020, which is conducive to reducing the operating costs of enterprises and alleviating the pressure on cash flow.

3 rubber industry projects were nominated for the National Science and Technology Award

On March 3, the National Science and Technology Awards Office announced the 24 National Science and Technology Award acceptance projects. Three rubber industry-related projects were shortlisted, namely: olefin controllable coordination polymerization method and high-performance elastomer preparation technology, key technology and industrial application of special extrusion molding of rubber products, and development and application of key technology standards for styrene-butadiene rubber.

Pollution discharge permit application and issuance of national standard release

On March 3, the Ministry of Ecology and Environment issued five national environmental protection standards for the application and issuance of technical specifications for pollution discharge permits with Announcement No. 30 of 2020, which will be implemented from the date of promulgation. Among them, there are two items involving the rubber industry: "Technical Specifications for Pollution Discharge Permit Application and Issuance Rubber and Plastic Products Industry" (HJ23-5) and "Technical Specifications for Pollution Discharge Permit Application and Issuance for Footwear Industry" (HJ2-1122).

Softcontrol realizes "remote acceptance of equipment" for the first time

At the end of March and the beginning of April, Softcontrol helped customers realize the "air" acceptance equipment of African and European factories through MR mixed reality technology, and innovated the acceptance method of equipment during the epidemic period. The customer's technical personnel do not need to arrive at the site, and can realize remote inspection through the

computer. In the specific operation process, the soft control engineer wears MR glasses, and the customer can see the real-time panorama of the equipment in the factory on the computer through the network connection, fully understand the overall situation of the equipment and related details, and communicate in real time through video dialogue. MR high-definition, all-round video picture real-time transmission, so that customer technicians as if they are in the scene, to achieve the effect of field inspection.

Linglong Tire Jilin project launched

On April 4, Jilin Linglong's 15.5 million tires intelligent production project was launched in Changchun, the fifth production base in China and the seventh production base in the world. The total investment of the project is 7.1420 billion yuan, and the construction scale is 48 million semi-steel tires, 93 million all-steel tires and 1200,200 retreaded tires per year.

Times new material rubber waterstop belt is the first immersed tunnel

On April 4, the first waterstop of the Xiangyang East-West Axis immersed tunnel undertaken by CCCC-17 was installed, and the waterstop and immersed concrete were successfully occluded. This new waterstop is successfully developed by Zhuzhou Times New Materials Company, which is the first time that China's self-developed high-performance rubber waterstop has been used in the construction of immersed tunnels, breaking the international monopoly. The test results show that the sealing, water-stopping, stability, etc. of the waterstop all meet the European standard, and some indicators even exceed the European standard. It is reported that the total length of the Xiangyang east-west axis immersed tunnel is 1.01 kilometers, and the design of 6 lanes is <> lanes, and its construction is of great significance to lead the development of inland immersed tunnel technology.

All steel and semi-steel tires of the Pulin Chengshan plant in Thailand rolled off the production line smoothly

On April 4, the first semi-steel tire of Pulin Chengshan Tire (Thailand) Co., Ltd. successfully rolled off the production line. Pulin Thailand started construction in March 18, and the first phase of the project is scheduled to be put into operation in the second quarter of 2019, with an annual output of 3 million semi-steel tires and 2020,400 all-steel tires. The project adopts the leading design concept of the tire industry and is designed with the standard of green intelligent manufacturing. Previously, the first all-steel tire in Pulin Thailand was successfully rolled off the production line on March 80.

China led the release of 4 international standards for tire RFID

On April 4, led by Softcontrol Co., Ltd. (main drafting), many countries participated in the drafting of four international standards for RFID electronic tags for tires were released. They are: "Radio Frequency Identification Tag for Tires", "Radio Frequency Identification Tag Code for Tires", "Radio Frequency Identification Tag for Tires - Classification of Tire Use", "Conformity Test Method for RFID Tires". The four international standards were officially established in October 20 and were developed by the WG4 "RFID tyre tags" working group of the International Technical Committee for Standardization of Tires, Rims and Valves (ISO/TC4). The four international standards of RFID electronic tags for tires are the first batch of international standards established and released in ISO in the Chinese tire industry.

The China Rubber Association promoted the standard online for the first time

On April 4, the China Rubber Industry Association held a standard publicity meeting on the "Pollution Discharge Permit Application and Issuance of Technical Specifications for Rubber and Plastic Products Industry" for the first time during the epidemic. According to the requirements of the Ministry of Ecology and Environment, all rubber product industrial pollutant dischargers must complete the clean-up and rectification by the end of April, and complete the issuance and registration of pollution discharge permits by the end of September.

The final ruling of the "double-reverse" administrative review of PCR tires in China by the United States

On April 4, the U.S. Department of Commerce issued an announcement to make the third final anti-dumping administrative review ruling on imported passenger car and light truck tires originating in China. The ruling ruled that 22 enterprises, including Shandong Newland Rubber Technology Co., Ltd., had a dumping margin of 19.0%; 00 enterprises, including Pirelli Wheel Co., Ltd., Qingdao Aorixin Tire Co., Ltd., and Tianjin Wanda Tire Group Co., Ltd., received a universal tax rate of 3.76%; China's general dumping margin is 46.76%. Previously, on April 46, the US Department of Commerce released the final ruling of the third annual administrative review of anti-dumping and countervailing duties on passenger car and light truck tires in China. In terms of countervailing measures, it was ruled that the tax rates of Jiangsu Kunshan Gouba Tire Co., Ltd. and Shandong Longyue Rubber Co., Ltd., two compulsory respondents, were 4.17% and 17% respectively, while the tax rate of the other 15 non-compulsory respondent enterprises participating in the countervailing review was 27.25%.

Brazil launched an anti-dumping sunset review investigation against China

On May 5, Brazil's Ministry of Industry and Foreign Trade Services issued a case registration announcement, announcing the launch of an anti-dumping sunset review investigation on new pneumatic truck and bus tires (products under investigation) imported from China. According to the filing announcement, the applicant alleged that the dumping margin of the Chinese company was R\$4.26 (about US\$61.4) per kilogram. The product under investigation is a tire for a new pneumatic truck and bus, with rim sizes of 771, 20 and 22.22 inches, and the tariff number in question is 5.4011.20.

The Ministry of Industry and Information Technology issued new regulations for the comprehensive utilization of waste tires industry

On May 5, the Ministry of Industry and Information Technology issued an announcement to issue two new regulations, namely the "Standardized Conditions for the Comprehensive Utilization of Waste Tires Industry (7 version)" and the "Interim Measures for the Management of the Announcement of the Comprehensive Utilization of Waste Tires Industry Specifications (2020 version)", while abolishing the original "Access Conditions for the Tire Retreading Industry", "Access Conditions for the Comprehensive Utilization of Waste Tires Industry" and "Interim Measures for the Management of the Access Announcement of the Comprehensive Utilization of Waste Tires Industry".

The first ultra-large plate vulcanizing machine in China was successfully developed

On May 5, the first 11.2×4-meter ultra-large steel wire rope core plate vulcanizing press production line independently innovated and developed by Yiyang Rubber and Plastic Machinery Group Co., Ltd. was successfully produced, leading the flat vulcanization equipment manufacturing industry to develop in a more energy-saving, high-efficiency and intelligent direction.

USW applied for a "double-reverse" investigation of PCR tires in Thailand and other countries

On May 5, the United Steelworkers (USW) filed an application with the U.S. Department of Commerce and the U.S. International Trade Commission (ITC) to initiate anti-dumping investigations on passenger car and light truck tires ("Products under investigation") from South Korea, Thailand and Taiwan ("Products under investigation"), and antidumping and countervailing duties investigations on Products under investigation from Vietnam.

Guilin Rubber Machine's first 77-inch new dual-mode hydraulic vulcanizing press was delivered

On May 5th, the first new dual-mode hydraulic vulcanizing machine of 18-inch engineering tires independently developed by Guilin Rubber Machinery Co., Ltd. was officially shipped to domestic customers. Compared with the traditional engineering tire mechanical vulcanizing machine, under the dual-mode configuration of the same specification, the machine has six advantages, such as saving more than 77% of floor space, higher repeatability, completely independent left and right molds, energy saving, environmental protection, high efficiency, low noise, shortening of vulcanization auxiliary time by nearly 20%, and large maintenance space.

India launched an anti-dumping sunset review of Chinese carbon black

On May 5, the Indian government launched the second anti-dumping sunset review investigation into carbon black products imported from China and Russia. The case concerned products under the Indian Customs Code 20. At the end of 28030010, India opened anti-dumping investigations into carbon black products originating in China, Australia, Iran, Malaysia, Russia and Thailand. On January 2008, 2010, India imposed anti-dumping duties on the products involved in Australia, China, Russia and Thailand. On October 1, 2018, India made its first final anti-dumping review of rubber carbon black originating in or imported from China, Russia and Thailand; On November 2015, 2018, India officially imposed anti-dumping duties for a period of five years on the products originating in or imported from China and Russia.

The first child of the 300 million PCR expansion project in Vietnam rolled off the production line

On May 5, the first semi-steel tire of the 25 million PCR expansion project of the Sailun Vietnam plant officially rolled off the production line, with a product specification of 300/235R55 BH18. The project is one of the major projects of the Vietnam factory in 15, using industry-leading technology and equipment, mainly to produce high-end, large-inch semi-steel tire products.

India launched an anti-dumping investigation against two rubber products from China

On May 5 and 26, India's Ministry of Commerce and Industry successively issued announcements to launch an anti-dumping investigation of China's nitrile rubber and rubber additives PX-27. On the 13th, in response to the application submitted by Apcotex Industries Limited, an Indian domestic enterprise, an anti-dumping investigation was initiated on nitrile rubber originating in or imported from China, the European Union, Japan and Russia. On the 26th, in response to the application submitted by the Indian domestic enterprise NOCIL Limited, an anti-dumping investigation was launched against the rubber additive PX-27 (Rubber Chemical PX-13) originating in or imported from China, South Korea and the United States.

"2020 China Rubber Annual Conference" was grandly opened online

On May 5, the world's largest rubber industry conference "28 China Rubber Annual Conference" organized by China Rubber Industry Association was grandly opened in the form of video online. The agenda of the meeting is scheduled for three days, which are May 2020, June 3 and June 5. The theme of this year's annual meeting is "Cohesion, Forge Ahead - New Era for a New Future". The meeting invited well-known international and domestic experts to share and exchange the impact of the epidemic on the domestic economic environment, the development of China's rubber industry, the rubber tire market situation in Europe, the United States and other countries, the domestic production and sales of rubber and policy changes; In particular, the "Listening to the Voice of Enterprises" session was arranged, and the chairmen of some professional branches (special committees) were invited to introduce the response measures and operation of their industries under the epidemic; The heads of key tire enterprises were specially invited to connect with you via video to share their experience and analyze hot and difficult issues in the industry.

"Liquid gold" engineering has made another breakthrough

On June 6th, the world's first invention and revolutionary green new material EVE rubber industrialization project - Yikai New Materials Co., Ltd. with an annual output of 9,30 tons of chemical rubber refining project officially started construction in Qingdao. The project is planned by the National Rubber and Tire Engineering Technology Research Center, the international pioneer invention of Yiwei Rubber Research Institute, and the engineering technology development and industrialization construction undertaken by Yikai New Materials Co., Ltd. The project adopts a new type of chemical rubber mixing technology completely independently developed, which completely subverts the physical dry mixing method of rubber and filler that has been used in the rubber industry for a hundred years, breaks through the traditional classical wear theory in the field of rubber materials, and is known as the "fourth milestone" original innovation technology in the

field of rubber tires in the industry. The breakthrough in the industrialization of this technology will greatly improve the performance of rubber tire products and promote the rapid iterative upgrading of the entire industry.

Sailun released the "Rubber Chain Cloud" industrial Internet platform

On June 6, at the online "11 China Rubber Annual Conference" held by the China Rubber Industry Association, Sailun Group officially released the world's first rubber industry Internet platform put into use - Rubber Chain Cloud. Through the rich mechanism model, big data platform and IoT integration of the rubber industry, the platform meets the complex manufacturing mode of the industry and provides professional and rich software services and APP applications for different business scenarios. At present, the platform has linked more than 2020, <> partners, and has achieved relatively mature product applications and solutions in major fields such as intelligent manufacturing, digital marketing, smart supply chain, collaborative target R&D system, and digital operation.

Jinyu Tire's overseas plant started operations in Vietnam

On June 6, Jinyu Tire Group's annual output of 18 million all-steel tires project laid the foundation stone in Phuc Dong Industrial Park, Xining Province, Vietnam. The factory will adopt the leading design concept of the tire industry, plan and design according to the overall goal of digitalization, intelligence and leanness of the factory, and adopt advanced technologies such as the Internet of Things, big data, fully automatic robots, and fully automatic high-bay three-dimensional warehouses to realize unmanned, automated and intelligent warehousing, logistics and other functions.

Tianjin Guolian 59/80R63 all-steel giant tire rolled off the production line

On June 6, the first 30/59R80 giant all-steel engineering radial tire independently developed and manufactured by Tianjin International United Tire and Rubber Co., Ltd. successfully rolled off the production line, becoming one of the few 63-inch all-steel giant tire manufacturers in the world. With a diameter of 63mm, a width of 4022mm and a weight of 1470.6 tons, the all-steel giant tire is the largest all-steel giant tire used in mining dump trucks, marking that the R&D and manufacturing capabilities of Tianjin Guolian all-steel giant tire have reached a milestone new stage on the basis of the domestic leading level.

Beijing-Tianjin-Hebei will cultivate a number of leading enterprises in the utilization of waste rubber

On July 7, the Ministry of Industry and Information Technology issued the "Beijing-Tianjin-Hebei and Surrounding Areas Industrial Collaborative Transformation and Upgrading Plan for Comprehensive Utilization of Industrial Resources (3-2020)". The plan proposes that by 2022, 2022 industrial agglomeration areas with distinctive characteristics will be formed, 30 industrial innovation centers will be built, and 50 innovative backbone enterprises will be cultivated; The regional coordination mechanism is relatively perfect, and a new pattern of resource recycling industry development with bulk agglomeration, green and high value, and efficient coordination has been basically formed. The opinions also proposed to promote the efficient use of waste polymer materials, implement the normative conditions of waste tires and waste plastics industry, build a number of old tire retreading projects, fine rubber powder preparation, recycled plastic granulation and other projects, and cultivate a number of processing and utilization leading enterprises in Dingzhou, Shandong Jinan, Henan Jiaozuo, Shanxi Pingyao and other places.

Race wheel creates the industry's first device voiceprint library

On July 7, Sailun Group signed a strategic cooperation agreement with a wholly-owned subsidiary of iFLYTEK to jointly build the "Rubber Tire Industry Artificial Intelligence Joint Innovation Center" and create the first "Rubber Industry Equipment Voiceprint Library" in China to promote the deep integration of artificial intelligence and rubber tire industry.

The preliminary decision of the US ITC vote found that it constituted substantial damage

On July 7, the U.S. International Trade Commission (ITC) voted to make a preliminary anti-dumping industrial injury ruling on passenger car and light truck tires imported from South Korea, Thailand, Vietnam and Taiwan, and a preliminary anti-dumping industrial injury ruling on passenger car and light truck tires imported from Vietnam, unanimously finding that the imports of the products involved in the above countries and regions constituted substantial damage to the domestic industry of the United States.

Triangle Airlines tires passed dynamic simulation tests

On July 7, Triangle Tire Co., Ltd. reported that the 14×30.8R8 specification product of the civil aviation radial tire developed by it (the front tire of the A15 passenger aircraft) recently carried out a dynamic simulation test in Xianyang, and successfully passed the 320 tests stipulated by the civil aviation standard CTSO-C62e, and the tire was intact after the test.

10 rubber companies won the 14th China Patent Award

On July 7, SIPO issued the decision to award the 14th China Patent Award. Among them, the patents of 3 enterprises of Shandong Shengquan New Materials Co., Ltd., Sinopec and Jiangsu Hengli Chemical Fiber won the China Patent Silver Award; The patents of 7 enterprises and universities, including Bekaert, Zhuzhou Times New Materials, Wanli Tire, Guangdong Yizumi Precision Injection Technology Co., Ltd., China Rubber Resources Recycling (Qingdao) Co., Ltd., and Qingdao University of Science and Technology, won the China Patent Excellence Award.

The China Rubber Association held a meeting of the Secretary-General to plan the work in the second half of the year

On July 7~15, the China Rubber Industry Association held the 16 Secretary-General's Work Conference online to summarize the development of various rubber industries in the first half of the year and the work of the association, discuss the work plan for the second half of the year and predict the development trend of the industry. The secretaries-general of each branch (committee) briefly analyzed the impact of the epidemic on the operation of various industries in the first half of the year, as well as the impact of the epidemic on the work in the first half of the year and the response measures; In view of how to carry out the normalization of epidemic prevention and control in the second half of the year, ideas and methods were exchanged. In addition, the meeting also focused on the preparation of the 2020th Five-Year Plan. In the final summary, President Deng Yali spoke highly of the achievements made by various branches and departments in organizing and coordinating the fight against the epidemic, promoting the resumption of work and production, summarizing industry difficulties to win government policies, organizing online activities to serve the industry, conducting industry research and developing new members, and believed that the association has given full play to the role of the platform and withstood the test of the epidemic.

Baotong signed a five-year procurement framework agreement with BHP Billiton

On July 7th, the launching ceremony of the new contract for the supply of Baotong-BHP conveyor belt (15~2020) was held in Wuxi Baotong Technology Co., Ltd. Baotong and BHP have launched a five-year conveyor belt procurement framework agreement, which is the first time that Baotong has signed a contract with six subsidiaries of BHP, covering BHP's Australian iron ore, coal, copper and nickel mines.

Double Star Mixed Reform officially signed

On July 7, the signing ceremony of mixed ownership reform of Double Star Group was held in Qingdao. With the signing of this agreement, Double Star Group introduced three strategic investors and "employee shareholding platform" by means of capital increase and share expansion and simultaneous equity transfer, Tus Science and Technology City Group Co., Ltd., Qingdao West Coast New Area Integration Holding Group Co., Ltd., and Shandong Xincheng Hengye Group Co., Ltd. According to the agreement, after the completion of all the investment, the shareholding structure of Double Star Group will be changed to: Qingdao City Investment Group holds 16% of the equity, Tus

Science and Technology City holds 3% of the equity, Financial Control Group and Xincheng Hengye each hold 41.35% of the equity, and the "Employee Shareholding Platform" holds 4% of the equity. In addition, the double-star mixed reform adheres to the party's leadership not weakening, insists on not losing state-owned assets, and highlights the "four new" characteristics of "new strategy, new resources, new mechanism, and new governance".

Turkey launches third sunset review investigation into motorcycle tires

On July 7, the Turkish Ministry of Trade issued Announcement No. 22 of 2020, initiating an anti-dumping sunset review investigation on motorcycle tires originating in China, Thailand, Indonesia and Malaysia. The Turkish customs tariff numbers of the products involved were 17.4011, 40.4013.90.00.00 and 11.8714.10.30.00 respectively. On July 00, 2015, Turkey made the second anti-dumping sunset review affirmative final judgment on the case, imposing anti-dumping duties of 7%~25%, 37%~100%, 68%~100.0%~19% and 6.29%~19% respectively on the products involved in the case, which were valid until July 6, 29.

The large aircraft "Kunlong" is equipped with domestic aviation tires and goes to sea

On July 7, China's self-developed large-scale firefighting/water rescue amphibious aircraft "Kunlong" AG26 successfully achieved its first flight at sea in the waters near Qingdao, Shandong. Shuguang Rubber Industry Research and Design Institute delivered and equipped 600 front tires and 2 main tires independently developed for the landing gear system of this type of aircraft, all with a rated speed of 4 km/h.

Saixiang BOOSTER all-steel forming machine achieved a shift output of 180 pieces

On July 7, Saixiang Technology Co., Ltd. announced that its self-developed BOOSTER series all-steel radial tire forming equipment has recently achieved a single-shift output of 31 embryos in customers, breaking the record of single-shift output of customers, marking that Saixiang Technology's molding machine technology has been at the world's advanced level.

The Eurasian Economic Commission launched an anti-dumping sunset review of Chinese truck tires

On August 8, the Eurasian Economic Commission issued Announcement No. 19/2020/AD228R18, initiating the first anti-dumping sunset review investigation on imported truck tires originating in China. The tax ID of the product involved in the case is 1 and 4011201000. On September 4011209000, 2014, the Eurasian Economic Union launched an anti-dumping investigation on imported truck tires originating in China; On November 9, 1, it was decided to impose anti-dumping duties of 2015.11%~18.14% on the products involved in the case in China, and the resolution took effect on December 79, 35 and was valid for 35 years.

Ningbo Tianpu Rubber was listed on the Shanghai Stock Exchange

On August 8, Ningbo Tianpu Rubber Technology Co., Ltd. (stock abbreviation "Tianpu Shares", stock code 25) was listed on the Shanghai Stock Exchange. The number of shares issued by Tianpu in this public offering is 605255.3352 million shares, and the issue price is 12.66 yuan per share. The net funds to be raised are about 36216.6 million yuan, which will be invested in the construction project of medium and high pressure hose production base, the innovation capacity building project of automobile lightweight pipe fittings and the construction project of assembly production line.

Two heroes of the rubber industry fighting the epidemic were commended by the state

On September 9, the National Commendation Conference for Fighting the New Crown Pneumonia Epidemic was held in the Great Hall of the People in Beijing. Xi Jinping, General Secretary of the CPC Central Committee, President of the People's Republic of China and Chairman of the Central Military Commission, presented medals and medals to recipients of national medals and national honorary titles and delivered important speeches. Zhou Haijiang, Secretary of the Party Committee and Chairman of the Board of Hongdou Group Co., Ltd., and Chang Min, Secretary of the Party

Committee and General Manager of ChemChina Shenyang Rubber Research and Design Institute Co., Ltd., won the honorary title of "Advanced Individual in the National Fight against the New Crown Pneumonia Epidemic"; Zhou Haijiang was awarded the honorary title of "National Outstanding Communist Party Member".

Zhongce Rubber and Pulin Chengshan Energy Efficiency "lead" the tire industry

On September 9, the list and indicators of energy efficiency "leaders" of key energy-consuming products in the petroleum and chemical industry in 4 were officially released. After deducting the corresponding issuance expenses, Sen Kirin raised about 12.12 billion yuan this time, and will invest in the project with an annual output of 09,8 aviation tires (including 5, <> retreaded tires), R&D center upgrade projects and supplementary working capital.

ZCX40A automatic three-drum forming machine is positioned as an all-steel forming machine for world-class high-end customers, and is also one of the company's highest specifications and most complex forming machines.

The United States issued a preliminary anti-subsidy ruling on Vietnamese passenger and light truck tires

On November 11, the U.S. Department of Commerce released the preliminary anti-subsidy ruling on passenger and light truck tires in Vietnam. The U.S. Department of Commerce has identified a number of subsidies, including exchange rate undervaluation and income tax incentives, which is the first time that the U.S. government has made a subsidy determination for undervalued exchange rates and imposed countervailing duties. In this preliminary ruling, Kumho Tire (Vietnam) Co., Ltd. received a subsidy of 4.10% and Sailun (Vietnam) Co., Ltd. received 08.6%; The subsidy range for all other Vietnamese enterprises is 23.6%.

The list of green manufacturing in the petrochemical industry was announced

On November 11, the China Petroleum and Chemical Industry Federation organized experts to identify the "bead wire I-wheel intelligent packaging production line" project jointly completed by Shandong Daye Co., Ltd. by industry, education and research. The appraisal committee unanimously agreed that the overall technology of the project has reached the domestic leading level, among which the tension adaptive control technology of functional paper wrapping has reached the international advanced level. The production line can save about 23% of the labor quantity, effectively reduce the intensity of workers' work and save the amount of packaging materials. The subject has applied for 50 patents, including 19 authorized invention patents, 7 computer software copyright registrations, and independent intellectual property rights.

The 21st National Rubber Industry Information Conference was held

On November 11~24, China Rubber Industry Association held the "Ninth Executive Director Enlarged Meeting of the Ninth Session of China Rubber Industry Association, the 26st National Rubber Industry Information Conference, and the "Rubber Industry '14th Five-Year Plan' Development Planning Guidelines" Press Conference in Suzhou.

The "14th Five-Year Plan" for the rubber industry was released

On November 11, at the 25st National Rubber Industry Information Conference, the China Rubber Industry Association officially released the "Guiding Outline of the 14th Five-Year Plan for the Development of the Rubber Industry" (hereinafter referred to as the "Plan"). The Plan covers 2025 industries in the rubber industry chain and provides guidance for the development of the 14th Five-Year Plan to seize opportunities and meet challenges. The development goal of the Plan is to achieve transformation through digitalization, intelligence, platform and greening through structural adjustment, scientific and technological innovation and green development, promote quality change, efficiency change and power change, and achieve higher quality, more efficient, fairer, more sustainable and safer development. Strive to enter the intermediate stage of rubber industry power by the end of the "14th Five-Year Plan" (2025).

From 2021, the import of waste rubber products will be completely banned

On November 11, the Ministry of Ecology and Environment, the Ministry of Commerce, the Development and Reform Commission, and the General Administration of Customs jointly issued the Announcement on Matters Related to the Comprehensive Prohibition of the Import of Solid Waste (No. 25 of 2020), clarifying that from January 1, 2021, China will completely prohibit the import of solid waste in any way, prohibit the dumping, stacking and disposal of solid waste outside China, and the Ministry of Ecology and Environment will no longer approve and issue import licenses for

solid waste that can be used as raw materials for import. The solid waste imported by China is mainly concentrated in waste plastics, waste paper, waste rubber products, rare metal smelting, slag and other types.

Double Star and Pingdu City jointly built a "shared" rubber refining center

On November 11th, Shuangxing signed a strategic cooperation agreement with Pingdu Rubber Chamber of Commerce and Qihang United Rubber Technology on the "Sharing" Green Rubber Refining Center Project. With a total investment of 26 million yuan, the project is located in Mingcun Town Polymer Materials Industrial Park, Pingdu City, using the technical advantages, equipment and procurement capabilities of Shuangxing, integrating the existing rubber demand resources of Pingdu and Qihang shareholders, and jointly developing high-performance, low-energy consumption and pollution-free green rubber materials. Qihang United is a joint venture company led by Pingdu Rubber Industry Chamber of Commerce and spontaneously established by 4 tire backbone enterprises and shareholders.

CAIC Yancheng invested 14.6 billion yuan to build a test site

On November 11, the launching ceremony of the "Yangtze River Delta (Yancheng) Intelligent Networked Vehicle Proving Ground" was held in Dafeng Port Economic Zone in Yancheng, Jiangsu. The project is invested and built by China Automotive Research Institute Automobile Proving Ground Co., Ltd. (CAIC Proving Ground), located in the northeast side of CAIC Proving Ground, with a planned land acquisition area of about 28,1582 mu, a planned total investment of about 13.76 billion yuan, and a construction period of about 30 months. The China Automotive Proving Ground will be planned and built according to the intelligent networked vehicle test base with the most comprehensive scene, the most professional facilities and the most advanced technology, and become a world-leading automobile R&D and testing cluster.

Ningbo Tuopu chose a site to build a factory overseas in Poland

On December 12, Ningbo Tuopu Group Co., Ltd. (SZ 1) announced that it will invest in the construction of a factory in Poland, with an estimated total investment of no more than 601689 million euros. The announcement revealed that the name of the new wholly-owned subsidiary is "Tuopu Poland GmbH", with a registered address in Warsaw, the capital of Poland, and an initial registered capital of 3000 million zlotys (200 Polish zloty = 1.1 yuan). The company's business scope is auto parts manufacturing, sales, automotive electronics and electronic equipment manufacturing, other auto parts manufacturing.

The Ministry of Industry and Information Technology released a list of technological innovation demonstration enterprises

On December 12, the Ministry of Industry and Information Technology released the "3 National Technology Innovation Demonstration Enterprise List". Shandong Haomag Machinery Technology Co., Ltd., Anhui Shengao Chemical Technology Co., Ltd., Zhonghao Chenguang Chemical Research Institute Co., Ltd. and other 2020 enterprises were selected.

Chengcheng shares "cloud gong" listed

On December 12th, the listing ceremony of the initial public offering of A-shares by Silicon Chemical Co., Ltd. was held in the form of "cloud gong" at Wuxi Taihu Hotel. Chengcheng shares (stock code: 7) issued 605183 RMB ordinary shares (A shares) for the initial public offering, and after deducting relevant issuance expenses, the raised funds of 48720375.62471 million yuan are intended to be used for three projects: an annual output of 60,3 tons of water glass, 7,7 tons of high-dispersion silica for green tires, a research and development center construction project, and supplementary working capital. The company will take this opportunity to become a digital, intelligent, green and sustainable development industry benchmark enterprise, and realize the company vision of "becoming the world's first in the industry within 5 years".

The fourth "double-reverse" review of the United States against Chinese passenger tires is the preliminary ruling

On December 12, the U.S. Department of Commerce released the preliminary ruling of the fourth review of China's countervailing car and light truck tires. Shandong Duolux Rubber Co., Ltd., Shandong Longyue Rubber Co., Ltd., Shandong Anchi Tire Co., Ltd., and Triangle Tire Co., Ltd. refused to cooperate with the investigation, and the US Department of Commerce applied the presumption of facts to rule that the tax rate was 14.116%. Jiangsu Hankook Tire Co., Ltd., Qingdao Fulin Tire Co., Ltd., and Shandong Sanli Tire Manufacturing Co., Ltd. are unselected companies, and their tax rate is 50.20% based on the average tax rate of the previous survey.

On June 6, the U.S. Department of Commerce released the preliminary ruling of the fourth review of anti-dumping of passenger car and light truck tires in China, in which two compulsory respondents, Shandong Longyue Rubber Co., Ltd. and Qingdao Aozhixin Tire Co., Ltd., received a dumping tax rate of 12.76% for refusing to participate in the investigation, and seven enterprises, including Qingdao Senqilin, and Shandong Linglong Tire, received zero tax rates.

The Ministry of Commerce ruled to impose a tax on imports of EPDM

On December 12, the Ministry of Commerce issued an announcement that from December 18, anti-dumping duties will be imposed on imported EPDM rubber originating in the United States, South Korea and the European Union for a period of five years. Anti-dumping duty rates levied on companies in various countries: 12.20%~5.214% for US companies, 9.222%~0.12% for Korean companies, and 5.24%~5.14% for EU companies.

The Petrochemical Federation Science and Technology Award was released

On December 12, the China Petroleum and Chemical Industry Federation commended 24 achievements of technical invention awards and 37 achievements of scientific and technological progress awards, and 197 projects from the rubber tire industry won awards. Among them, there are 9 first prizes and 2 second prize for technological invention, 1 first prize, 1 second prizes and 2 third prizes for scientific and technological progress. In addition, Zhang Liquan, vice president and professor of Beijing University of Chemical Technology, was awarded the "Zhao Yonghao Science and Technology Innovation Award"; Tian Hongchi, deputy general manager of Shandong Dawn Polymer Materials Co., Ltd., was awarded the "3 Youth Science and Technology Outstanding Contribution Award".

Hefei Wanli won the China Industry Award Commendation Award

On December 12, the 27th China Industry Awards Conference was held in Beijing. Hefei Wanli Tire Co., Ltd.'s "Green Radial Tire Intelligent Innovation Industrial Demonstration Project" won the commendation award of this China Industry Award, becoming the only shortlisted rubber tire enterprise.

Wuxi Baotong Technology Center was promoted to national level

On December 12, the National Development and Reform Commission and other 28 departments jointly released the list of national enterprise technology centers in 5 (the 2020th batch), and the technology center of Wuxi Baotong Technology Co., Ltd. was upgraded to the national level, which is the only enterprise from the rubber industry among the 27 new technology centers, becoming the 107nd national enterprise technology center in the rubber industry, and the first national enterprise technology center in the conveyor belt industry.

The China Rubber Association standard entered the list of application demonstration by the Ministry of Industry and Information Technology

On December 12, the Ministry of Industry and Information Technology released the 25 Group Standard Application Demonstration Project, and the "E Series Recycled Rubber" (T/CRIA 2020-21001) released by the China Rubber Industry Association was listed.

Guizhou Tire won the Governor's Quality Award

On December 12, the People's Government of Guizhou Province issued a document deciding to award the third Guizhou Governor Quality Award to three enterprises, including Guizhou Tire Co., Ltd.

The U.S. Department of Commerce issued the preliminary anti-dumping ruling

On December 12, the U.S. Department of Commerce announced an affirmative preliminary ruling on anti-dumping investigations into passenger car and light truck tires from Vietnam, South Korea, Thailand and Taiwan. The dumping margins are: Korean enterprises 31.14%~24.38%, Taiwan enterprises 07.52%~42.98%, Thai enterprises 44.13%~25.22%, Vietnamese enterprises 21%~0.22%. Among them, the dumping margin of Sailun Group (Hong Kong), Sailun Tire Americas and Sailun (Vietnam) was 3, and Linglong Thailand was 0.22%.
