Ten years of hard work has stirred people's hearts, and extraordinary achievements have gathered strength. As of the end of June 2022, the "Belt and Road" loan balance of the Shandong Provincial Branch of the Export-Import Bank totaled nearly 65 billion yuan, accounting for about 40% of the total loan balance. Help upgrade infrastructure and improve regional production and living conditions

In 2020, the Shandong Branch of the Export-Import Bank of China, together with the Corporate Customer Department of the head office, issued the first loan for the elevated expressway project at the Dhaka Airport in Bangladesh. In addition, the Shandong Provincial Branch of the Export-Import Bank handles the export financial information communication business for the third construction of the electric power company, provides financing support for its overseas seawater desalination projects, and helps alleviate the problem of local water resource scarcity; issues advance payments for overseas highways undertaken by Shandong Foreign Economic and Trade Co., Ltd. The letter of guarantee and the letter of performance guarantee provide an important financial guarantee for the construction work of the project. Each of the infrastructure cooperation projects not only leveraged the development of the local economy and society, but also built bridges of friendship one after another.

Guarantee foreign industrial investment and promote high-quality economic and social development

In the past ten years, more and more Shandong enterprises have gone abroad to carry out industrial cooperation with countries along the "Belt and Road", bringing real employment opportunities and development space to the local area. The Shandong branch of the Export-Import Bank has successively supported a number of industrial cooperation projects along the "Belt and Road" such as the overseas merger and acquisition project of Yankuang Energy, the 10 million high-performance semi-steel radial tire project of Century Tire, and the 500-ton glass project of Jinjing Technology. It relieves enterprises from worrying about financing when they "go global", and effectively promotes local employment and economic development.
