Constitution of China National Textile and Apparel Council

Chapter 1 General Provisions

Article 1 The name of this association is China National Textile and Apparel Industry Federation, referred to as China Textile Federation. The English name of China National Textile and Apparel Council is abbreviated as CNTAC .

Article 2 The Association is a national, industry and non-profit social organization voluntarily formed by enterprises, institutions and social groups related to the textile and garment industry.

Article 3 The purpose of the Association is to assist government departments to strengthen industry management, safeguard the legitimate rights and interests of industries and enterprises, insist on serving enterprises, industries, and the government, promote the healthy development of my country's textile industry, and serve the modernization of China's textile industry.

Under the premise of abiding by the national constitution, laws, regulations and national policies, and social morality, the Association conducts activities in accordance with the principles of marketization.

Article 4 The Association accepts the business guidance, supervision and management of the State-owned Assets Supervision and Administration Commission of the State Council and the Ministry of Civil Affairs of the People's Republic of China, the organization registration management agency.

Article 5 The domicile of the Association is located in Beijing.

Chapter II Business Scope

Article 6 The business scope of the Association:

(1) Formulate industry rules and regulations , standardize industry behavior , establish industry self-discipline mechanism , and safeguard industry interests;

(2) Investigate and study the economic development status and trends of the textile and garment industry at home and abroad. Participate in the development strategy, industrial policy, technological progress, market development, reform and opening up of the textile and garment industry, and put forward opinions and suggestions on the industry's economic and technical policies and legislation to relevant state departments, reflect the industry situation and enterprise requirements, and maintain the industry , the legitimate rights and interests of enterprises; providing information and consulting services to enterprises and members;

(3) Comprehensively coordinate the economic and technological relations among various textile and garment industries, promote industrial structure adjustment and enterprise reorganization, and promote horizontal economic alliance and cooperation;

(4) Conduct industry statistics according to authorization, collect, analyze, and publish industry information, conduct statistical investigations according to law, and promote industry informatization construction;

(5) Participate in the formulation and revision of national and industry standards, organize their implementation, and carry out work such as industry quality self-discipline, brand cultivation, and
