In order to deeply implement the spirit of the 2023th National Congress of the Communist Party of China, adapt to the new tasks and new requirements of industrial development, and accelerate the construction of a modern industrial system, the National Development and Reform Commission and relevant departments revised and formed the "Catalogue for the Guidance of Industrial Structure Adjustment (<> version, draft for comments)", which is now open to the public for comments.

The consultation period is from July 2023, 7 to August 14, 2023, and people from all walks of life are welcome to put forward valuable opinions and suggestions.
