Statement of the Company

March 17, 2021

In connection with Bloomberg and Forbes magazine publications regarding the possible allocation of SWF funds for Rosneft projects, the Company officially declares the following.

Rosneft did not appeal to the Government of the Russian Federation on the issue of raising funds for the implementation of its projects. The financial and economic model of the East Oil strategic project mentioned in the publications does not provide for the use of long-term public funding. These publications did not apply to the Company for official comments, as required by current legislation. In this regard, the scale of the false statements contained in these materials misinforming the market and society is surprising. The Company's lawyers are currently working on issues of protecting the interests of Rosneft and its shareholders and have sent relevant requirements for refutations to the editorial offices of these publications.
