The scope of this review

Goods Subject to Review

This review covers certain steel products imported into the United Kingdom (UK) as detailed in [Annex 1](#).

In this pre-sampling questionnaire, these goods will be referred to as 'the Goods Subject to Review'. Any reference to the 'Goods Subject to Review' in this pre-sampling questionnaire refers to the product categories and commodity codes set out in Annex 1.

Like Goods

This pre-sampling questionnaire asks for information about your company's sales of goods which are like the Goods Subject to Review. Any reference to 'Like Goods' in this pre-sampling questionnaire refers to goods produced in the UK which are like the Goods Subject to Review in all respects, or with characteristics closely resembling them.

Directly Competitive Goods

Directly Competitive Goods are goods produced in the UK which are directly competitive with the Goods Subject to Review.

This can include goods that are not only similar to the Goods Subject to Review, such as a different type or variety, but also include goods that occupy a position of direct competition with the Goods Subject to Review. A Directly Competitive Good may be one that is substitutable with the Goods Subject to Review.

Why you are being asked to complete this pre-sampling questionnaire

We are seeking your cooperation as a UK producer of the Like Goods or Directly Competitive Goods to inform our review of whether the current safeguards measure should expire or be extended. If you are not a UK producer, please complete either the relevant Pre-Sampling Questionnaire or the Other Interested Party and Contributor Registration Form.

This pre-sampling questionnaire allows us to collect basic information and data about your company. If a large number of UK producers complete this pre-sampling questionnaire, we will use the information each producer provides to help us decide which companies we want to sample for further investigation. If you are sampled, we will send you a more detailed questionnaire to complete.
