CARBIO wishes to take the opportunity of this transition review to determine with TRA whether the possible recourse to a price undertaking that would benefit both the UK market and the exporters concerned can be envisaged/discussed already in the context of the present review and/or in the context of any future interim review.

CARBIO understands that Regulation 99C could be read as seemingly excluding TRA’s discretion to consider undertakings in the course of transition reviews. However, in CARBIO’s view, this rule should not be construed in a way that would necessarily and automatically preclude consideration for undertakings altogether in the course of a transition review. In particular, pursuant to Regulations 77 and 78, TRA has discretion to recommend the Secretary of State to accept such undertaking in respect of a subsidization investigation. CARBIO will submit, in separate comments, its more detailed views on this particular issue. It will also discuss whether provisions allowing the Secretary of State to apply alternative remedies should be considered in the present case especially if any such remedies would be in the public interest.

Finally, CARBIO also wishes to stress that the UK is a net importer of the product concerned and that the existing price undertaking has been extremely beneficial in the EU market where it has greatly contributed to a stabilization of the EU market both in terms of volumes and prices.
