Goods subject to review

This review covers electric bicycles exported from the People's Republic of China, described as:

- Cycles, with pedal assistance, with an auxiliary electric motor.

These electric bicycles are currently classifiable within the following commodity codes: 87 11 60 10 00 and 87 11 60 90 10. These commodity codes are only given for information.

In this document, these goods will be referred to as 'the goods subject to review'. Any reference to 'goods subject to review' in this document refers to the goods description above, regardless of the commodity code under which they are exported.

Like goods

Any reference to '**like goods**' in this document refers to goods produced in the UK or imported to the UK from a country other than the People's Republic of China which are like the goods subject to review in all respects, or with characteristics closely resembling them.
