INITIATION OF SAFEGUARD REVIEW BY THE UNITED KINGDOM ON IMPORTS OF CERTAIN STEEL PRODUCTS UNDER CATEGORIES 4, 7, AND 12A

Reference is made to the initiation of the safeguard review by the United Kingdom Trade Remedies Authority (UK TRA) on imports of certain steel products as published by the WTO Committee of Safeguard in the Notices G/SG/N/10/GBR/1/Suppl.30 and G/SG/N/10/GBR/1/Suppl.31 dated 14 January 2026 on the following:

- i. Alloy merchant bars and light sections (Category 12A) under 7228 3020, 7228 3041, 7228 3061, 7228 3069, 7228 3070, 7228 3089, 7228 6020 and 7228 7010;
- ii. Metallic coated sheet (Category 4) under 7210 6100 20 and 7210 6900 80; and
- iii. Non-alloy and other alloy quarto plates (Category 7) under 7208 5191 00, 7208 5291 00, 7208 5198 00, 7208 5120 00, 7208 5299 00 and 7208 5120 10.
